In pursuance of an order to me Directed bareing date the tenth day of May one thousand seven hundred and Seventy One Requiring me to Survey unto the Devisees of Abraham Porter or his Assigns the Quantity of two — Hundred and fifty acres of Unappropriated Land Below the falls of Delaware River at Trenton and by Virtue of a Conveyance from John Stow (Devisee of the said Abraham Porter) unto John West of the same two Hundred and fifty acres By Deed dated the twenty first Day of September 1772 I have Surveyed for the said John West part thereof Situate in the County of Gloucester in the Western Division of New Jersey a Neck of Land Between Nescocheage (whereon John Wests Saw Mill is Erected) and Machiscotuason two Branches of Little Eggharbour River and is Bounded as follows Viz Beginning at a pine letter^d IW standing by the North side the s^d Nescocheage Creek little below the Sawmill and about Six perches below a small Gully and from thence Running /1st/ North twenty seven Degrees East forty two Chains to a pine Letter^d T.C.
