In Pursuance of an Order bearing Date y^e 175_ Ordering the full Quantity of Acres Land to be Surveyed unto Abraham Leeds in any part unappropriated in y^e Western Division of New Jersey I have Surveyed part of the Same in Two Separate Surveys both Situate in Gloucester County Lying on two Small Branches [that puts in a branch of Little Eggharbour River—Called Atsiunk] That is to Say on Survey lying on a Small branch that puts in the westerly Side of said Atsiunk and is Bounded as Followeth Viz: Beginning at a Forked Top pine marked four blazes Eight Nicks Standing in y^e Edge of y^e: Cripple the Southerly side of s^d Small branch and Runs from thence down the Same (1) South Seventy one Degrees East five Chains to a Corner near y^e head of a Saw Mill pond called Goshion Mill then a Cross s^d branch (2nd) North Nineteen Degrees East Two Chains Then (3rd) North Seventy one Degrees West five Chains Then (4th) South Nineteen Degrees West Two Chains to y^e place of Beginning in which bounds Contains one Acre of Cedar Swamp Strict measure— — —

The Other Survey Situate on a Small branch that puts in y^e Easterly Side of said Atsiunk and is thus Bounded Viz Beginning at a pine markt four blazes Eight Nicks Lettered /AL/ Standing in y^e Edge of y^e Cripple y^e Southerly side of said Small Branch Branch near y^e head of the Ceders and Runs from thence down y^e s^d branch (1st;) South Eighty one Degrees Thirty Minutes West Six Chains to a small pine markt four blazes Eight Nicks Standing near Some plains or meadow ground then Crossing said Small branch (2) North Nine Degrees West one Chain & Eighty five links to a post Then up y^e Swamp (3rd;) North Eighty one Degrees Thirty Minuits East Six Chains Then (4th;) South Nine Degrees East one Chain & Eighty five links to y^e place of Beginning in which bounds Contain one ^{acre} Acre and ~~Sixteen~~ Seventeen Arches of Cedar Swamp Strict measure — With the Usual Allowance for highways their Remains but Two Acres of Cedar Swamp in y^e: aforesaid Surveys.
